1. 2016 ANNUAL MEMBERSHIP MEETING

Requirement of prior notice:

- 1. Anyone submitting an AMHA Rule Change Proposal must be a current AMHA member in good standing for the proposal to be forwarded on to the proper committee. AMHA Staff may submit Rule Change Proposals. To be eligible for consideration by a standing committee a rule change proposal or amendment must be presented in writing and signed by the originator prior to the adjournment of the AMHA National Convention. All proposed Show Rule amendments must be presented with five (5) original co-signatures of AMHA members in good standing. All proposed amendments will be reviewed by staff, Executive Director (if applies), and then passed on with an impact statement to the appropriate committee(s) for evaluation. The affected committees will then review the proposed changes and word them in the appropriate legal terms. The committees cannot change the intent of the rule as it was received from its original source. The change will then be presented for consideration on the agenda of the appropriate committee at the mid-year Board of Directors Meeting. **Rule Proposals shall be submitted with the appropriate committee** recommendation If the rule change proposal is adopted by the committee it will then be voted on and approved by a majority of the Board of Directors.

The registry and stud book of The American Miniature Horse Association shall be closed, **with the exception of geldings and spayed mares**, effective December 31, 2013, after which all newly registered horses, **with the exception of geldings and spayed mares**, shall consist only of those horses with previously registered sires and dams. (Amended 02-08, effective 01/09)

Due to item #1451 being removed from Rules & Regulations, item #1435 is not necessary.

RULES & REGULATIONS

193 Hardship (Geldings and Spayed Mares) #1451 Submitted by: Pam Pruitt

The following procedures outline the steps which must be completed prior to the registration of a horse gelding and/or spayed mare through the Association's Hardship procedure.

193A. Application for Geldings and Spayed Mares Only

An AMHA Application for Registration, along with a letter requesting Hardship Registration must be submitted to the AMHA office. This request must be accompanied by four (4) current color unaltered photographs (effective on a voluntary basis January 1, 1998 and required by June 1, 1998) of the horse showing all identifiable markings and the proper fees for Hardship Registration. For Hardship registration a horse must be three (3) years of age or older. All Hardship horses except geldings must be DNA tested, effective January 1, 1998. <u>A veterinarian's statement (on letterhead) is required to prove the horse has been gelded or spayed.</u>

193B. Inspection

1. The AMHA office will contact a current or former AMHA Regional Directornearest theapplicant when possible. This current or former AMHA Directormust possess a currentAMHA certified measurer's card. This Director willarrange for and perform aninspection of the animal at a time mutuallyagreeable to both parties.

(Amended 02-09, effective 01-10) (Amended 02-12, effective 01-13)

2. The Inspector shall inspect the horse, noting in his/her report:

-the height of the animal

-major conformation faults, if any, using the AMHA Standard of Perfection as a guide, and other items that could disqualify a horse from an AMHA-approved show.

3. Certificates of Registration will be held by the AMHA office until all expenses are paid in full. The expenses related to inspection shall constitute a "non-refundable" fee for inspection and will be the responsibility of the applicant.

4. Inspection Fees

a. Expenses of the Inspector shall constitute a "nonrefundable" fee for inspection.

b. Expenses for this inspection shall be submitted to, and be reimbursed from the AMHA office upon the submission of an invoice, including all receipts.A list of applicable inspection fees may be obtained from the AMHA office.

- 5. Appeal
 - a. A horse may be appealed once.

Clarification: Effective January 1, 2011, appeals are not retroactive, but are only effective from the date of passing the rule forward.

- b. File shall be submitted to Executive Committee who will appoint a different inspector than the first.
- c. Expenses shall be reimbursed at the same rate as the first inspection.
- d. Decision of second inspector shall be final.

Office Reason:

*It is being requested by the AMHA Registration Department that the Hardship Registration procedure be re-opened for Geldings and spayed Mares only. The previously used registration process to hardship register would remain in place and still be required but allowing only Geldings and Spayed Mares (a report from the veterinarian would be required). And the requirement to DNA all Hardship horses would remain in place, but also include geldings and spayed mares with those records kept on file for identification purposes if needed.

The registration department wishes to re-instate the Hardship process to help offset at least a portion of the lost income generated by the Hardship registered mares and stallions and to accommodate the many new miniature horse owners who want to register their unknown parentage horses and are anxious to become involved in the AMHA. These horses would be allowed to show at all AMHA recognized shows and their owners could enjoy the perks of AMHA membership with a registered horse.

Case in point, here is a small excerpt from an email that was recently received: Hello, I have recently purchased a miniature horse and am just looking to see what potential is out there for him. I have been competing in Hunter/Jumpers for years, but have in inkling to learn something new. I was wondering if he has to be a registered miniature with a breeding back ground in order to become a part of AMHA, or to even show. I adopted him from a rescue agency and am sure he won't have papers. Also, are there clinics in BC for Miniature horses that you know of?

This is one of the many, many inquiries the AMHA receives and if we do not offer some way of reaching out to these "would be members", they will only have the option of going to AMHR. Keep in mind these entry level horses are the way we attract hundreds of new members- they become involved and buy more and better horses. Throughout our history that process is repeated again and again.

Note: If passed, Article XI – Registry and Stud Book, section 2 must be revised.

Bob Kane moved to remove item # 1451 due to the fact that hardship registration was closed as of December 31, 2013 and not enough time has passed to allow this item to be considered for a vote.

Rules & Regs - 150A (new) #1452 Submitted by: Harry Elder

American Miniature Horse Association (AMHA) policy for a complaint filed with the AMHA Office against an AMHA member. The following steps will be followed to maintain the protection of all parties concerned and applies to all AMHA members. A flow chart will be used in conjunction with the following guide lines.

- 1. When a formal complaint is received at the AMHA office, the complaint must be in the form of a letter that is dated, signed and a \$100.00 filing fee attached by the individual filing the complaint. If a telephone, email, or faxed complaint is received, the office manager will notify the individual that a dated letter with the original signature of the member filing the complaint must be mailed to the AMHA office with a \$100.00 fee for any action to proceed. Electronic signatures will not be accepted.
- 2. The office manager will forward the complaint to the President. If the complaint is against the President it will be forwarded to the Vice President. The complaint will be handled as sensitive information and will only be discussed with the Executive Committee (EC) during closed meeting, excluding any EC member that the complaint may be against.
- 3. The President or Vice President will review the complaint with the EC as outlined in #2. If the complaint is found to be a matter that AMHA has no control over or is outside the jurisdiction of the AMHA it will be sent back to the person filing the complaint with an explanation with in 30 days and the \$100.00 filing fee will be returned.
- 4. During the review, the EC will appoint an EC member

to represent the person filing the complaint and another EC member to represent the individual who the complaint was filed against. In the event that there is a conflict of interest with an EC member fulfilling these duties a member of the Board of Directors (BOD) will be appointed.

- 5. Each appointed EC/BOD member will conduct an investigation to
- 6. include an interview only with their appointed party. They will take statements concerning the complaint and will report back to the EC with their findings. If one or both parties want to present their side of the complaint to the EC another meeting will be scheduled. The President or Vice President will determine if both parties may be on the same call.
- 7. Once the investigation starts and while it is ongoing, the Complainant and the party which the complaint is filed against will be notified to not have any communication with each other until the EC completes its investigative processes.
- 8. During the final meeting every attempt will be made to protect individual rights and satisfactorily resolve the complaint between the parties involved. Every attempt will be made to keep this complaint from going forward to a Hearing Board however all information that has been gathered during the initial investigation will be forwarded to the Hearing Board if one is necessary.
- 9. The EC will decide if the Complaint has been resolved or whether a Notice of Charge should be issued. If a Notice of Charge is issued, the \$100 filing fee will be returned to the member filing the complaint. Both parties will be notified of the decision.

SHOW RULES

GR-025-Q; pg. 87 Submitted by: EC/BOARD

Q.

If the results are approved, the AMHA office will issue a statement of acceptance. If not, the show chairman will be notified with the option to correct the errors, or appeal to the Board of Directors. Show managers will be assessed a \$10.00 penalty for each violation of the show rules when show results are submitted and this penalty must be paid within 30 days of notification or result in forfeiture of rights to hold future shows. If a show chairman fails to file the results correctly, within the proper time, it may result in the withdrawal of the approval of that show and any future shows of that manager or organization, as well as the withholding of the points that horses would be entitled to as a result of their placement in the show.

Add : The AMHA office will verify all show results. If there are discrepancies in results, the Show Manager will be contacted in order to allow for corrections and/or explanation. If the Show Manager does not reply within 15 business days, excluding Holidays, the results will be accepted with the office's corrections. NOTE For example; if the person listed in an Amateur class is not eligible to show in that class; their entry will be disqualified. The intention is to allow the Show Managers a chance to verify with the exhibitors. Should they exhibit Gross Negligence in reporting correct show results, their status as an AMHA Show Manager could be in jeopardy and their actions would be reviewed by the Executive Committee. Below are 2 new Amateur/Performance rule change proposals. Please review and advise. We would like to get them both submitted with the blessings of *both* the Performance Committee and Amateur Committee.

VERSATILITY and YOUTH VERSATILITY VERSATILITY: Open, Amateur & Youth

A. The horse will perform three (3) disciplines in ONE (1) Class.
Harness Driving
Halter
Hunter (Abbreviated Course)
All three (3) disciplines to be judged equally and combined for final placing. Any horse disqualified from one (1) division is disqualified from the class.
1. There will be one (1) class: Stallion, Geldings and Mares.
2. Each division will be subject to the Open class rule for that division unless otherwise stated in class description.

3. Horse must be three (3) years of age or older.

4. No Youth twelve (12) & under may show a Stallion.
5. One (1) Assistant or Header (MUST BE AN ADULT) will be allowed in the arena only for the heading and un-harnessing of the horse.
Reference Header Rule: CL-030-H-4 and YD-010-H.
6. Exhibitor and assistant must be properly attired.
7. Class Procedure:

A. Horses will enter the arena at a pleasure trot or a country pleasure trot* then perform a working trot and walk in both directions of the arena. Headers will be asked to enter the arena. Horses will be asked to rein back.

B. The call judge will blow a whistle signaling the driver and header, as a team, to remove cart and harness from horse and do any grooming or halter changes. Each horse and handler will go to the rail in order of completion. After a two (2) minute time limit the call judge will blow the whistle for time. Any horse not removed from cart or harness will be disqualified. Headers will be asked to exit the arena with cart and harness, in an orderly manner.

C. HORSES ARE TO REMAIN IN THE SAME ORDER FOR THE REST OF THE CLASS AS THEY GO ON THE RAIL, BOTH FOR THE HALTER AND HUNTER PORTIONS

D. Horses will be judged at halter. No teeth will be checked. Horses will line up head to tail for inspection. Horses will not be asked to move.

E. Horses will jump a course of three (3) jumps. One (1) left turn to the inside may be demonstrated. Course is to demonstrate horses' style, manner and way of going.
*Cross-over rule CL-035-E does not apply to Versatility
This class will be optional at Local Shows and mandatory at
Championship Shows and the World Show.
Youth Versatility is optional and may be combined at Local Shows, but is mandatory at the Regional Championship and the World Shows as
12 & Under and 13 & over.

Individual jumps will be increased not less than one inch and not more than six inches in height for each jump-off. If the situation arises where none of the horses involved in the jump-off can complete the course without disqualification, first place will be awarded to the horse that got the furthest through the course before being disqualified. Should this still result in a tie. show management will have the option to lower and/or reduce the number of fences in the course. If this fails to break the tie, the winner will be determined by a coin flip. At Championship and World Championship Shows a jump-off will be held to determine the Reserve Championship/World Champions in all jumper classes as well as the Champions.

Stock Type Division

#1417

Standards of Conformation and Movement

GENERAL IMPRESSION – An attractive horse where everything is proportionate and all parts tie in smoothly. All gaits are smooth and purposeful exhibiting natural athleticism. Horses are judged on balance, structural correctness and sex characteristics. Of these, balance is the most important.

S TA N C E - The American Miniature Horse Association's Stock Type Horse normally stands at ease with his legs perpendicular to the ground and parallel with each other. The horse should exhibit a balanced stance and stand on the corners of his body, as opposed to being spread too far apart or crowded too close together, or parked out.

H E A D - The head of an AMHA Stock Type Horse reflects inquisitive intelligence. He has a short, broad head that is straight or slightly dished topped by small to medium ears hooked towards the center line at the tips; kind wide-set eyes; large nostrils; small muzzle, and firm mouth. A domed forehead is a fault.

BITE – When viewed from the side, the meeting point of the center incisor teeth should be

equal and even. A deviation of no more than half the width of the tooth's surface is permissible without fault.

 $N \in C K$ - The head of the AMHA Stock Type Horse joins the neck at a roughly 45degree angle, with a slender throatlatch allowing him to move easily in any direction while maintaining his balance. The medium to long neck should be slightly arched and blend smoothly into sloping shoulders.

SHOULDERS - The AMHA Stock Type Horse's short strong back is created by deep sloping shoulders tying in well back.


CHESTANDFORELEGS - As demonstrated by the heart girth and relatively wide-set forelegs, the AMHA Stock Type Horse is deep and broad in the chest. Smooth joints and short cannon bones are set on clean fetlocks and medium length pasterns are supported by healthy hooves. The forearm tapers to the knee, whether viewed from the front or back.

B A C K - The short back of the AMHA Stock Type Horse is full and strong across the loins. The barrel is formed by deep, well sprung ribs which extend to the hip joints. The underline, or abdominal area, should rise cleanly to the flank. The point of the croup should be no higher than the top of the withers. The tail is set off a long, rounded croup.

HINDQUARTERS - Viewed from either side or the rear, the hindquarters are broad, deep and adequately muscled through the thigh, stifle and gaskin down to the hock. When viewed from the rear, there is adequate width extending evenly from the top of the thigh to the gaskin. The hocks are wide set, deep and straight.

B ONE S, L E G S AND HO O V E S - Flat, strong bones, smooth joints and proper angulations form a leg that is attractive and functional. The hooves are proportionate to overall conformation

MUSCLING -The AMHA Stock Type Horse should have muscling adequate to function, but is not a heavily muscled breed. Overly heavy muscling is a fault. **MOTION-** Stock Type horses track straight and true. At all times they should appear confident, balanced and athletic, demonstrating a low flat stride with minimal knee and hock action.



Standards and Style

1. Stock Type division horses will be shown in a stock horse manner with the horse standing still, calm and square.

2. The handler should stand towards the left side of the horse's center line, more or less facing horse.

3. Stock type/western show halters will be the accepted standard. At local shows a nylon halter will suffice. An Arabian type halter is unacceptable and will result in disqualification.

4. Leads may have chains, but chains may only go under chin and not over the nose or in the mouth.

- 5. Razoring of heads will be heavily penalized. Clipping is permitted.
- 6. Banding or braiding of manes is prohibited.
- 7. Manes should be natural looking and of moderate length
- 8. Pulled, overcut or undercut manes are acceptable.
- 9. Tails should be off the ground.

Requirements

1. A horse may not show in more than one halter division at any show with the exception of color and/or Special Needs classes. Versatility is considered a performance class and this does not apply.

2. There will be no instances of halter competition between horses representing Stock Type and the other division such as supreme champion classes.

3. Current rules for handler's dress will apply in stock division.

4. Current halter ring pattern will be used for stock division.

The committee estimated conservatively that of the 19 sponsors that signed up, 17 would pay for 2015 which gives a total of \$7,500 for Futurity Awards. In 2014, the 19 Jackets for 1st place cost \$3,952 which leaves approximately \$3,548 remaining to cover Hats, T-shirts, Grand/Reserve awards, and ribbon costs above \$10 class credit.

Weanling Sweepstakes Classes

The Weanling Sweepstakes classes had nice entries in 2014. With the \$10 entry fee applied to the ribbons it was about break even for cost.

- Allison mentioned we should add the Geldings to the Weanling Sweepstakes classes. We asked Laura to add the Geldings to two of the existing classes on the World Show Class List. The classes for 2015 will be:
 - o Open Weanling Mares 30"& Under
 - o Open Weanling Stallions & Geldings 30" & Under
 - o Amateur Weanling Mares, Stallion & Geldings 30" & Under

Class fee + \$100 fee for payout. No cross entering will be allowed between open and amateur. We will not be giving display checks in 2015 since the amounts were so small. It was also suggested to change the payout so that the prize money would be bigger. This would mean fewer horses would receive a cash payout. It was decided that every 3 horses would pay one placing. For example: a class of 9 horses would payout to horses receiving 1st - 3rd place.

Awards: We had sashes for 3-10th place and many exhibitors walked out carrying the ribbon since the weanlings don't like to have them put on. We will continue with sashes for 1st & 2nd place for the win pictures and change to Top Ten ribbons for the 3-10 places. We will order the silver plates for the 1st & 2nd places & ribbons again through Laura as well.

Change in Judges

Exhibitors were not happy with using 5 Open Judges to judge the Halter Futurity Classes. The committee consulted with Laura and came up with the following alternative:

 Use 3 judges to judge the Halter Futurity Classes – 2
 Open judges and 1 Amateur judge to be retained from the Amateur Judges, with the day fee, meal per diem and hotel to be covered by the Futurity. Approximate cost of \$500

- The show program can use the Regional judging software for these classes without a problem. All judges placing will count in the final placings (no throw outs for high and low).
- It was suggested we could switch off using 2 Amateur and 1 Open judge in the even year to mix things up, depending on the overall cost to the Futurity.

The committee felt this was a good compromise for all of the exhibitors, as those competing in Amateur, Futurity and Open will have 3 different sets of judges for each division!

Some clubs no longer exist which I was able to figure out when their websites were no longer active. Many of the officers have changed and there is no longer a current active email listed. Many of my emails were returned due to this issue. I truly only received about 10 responses. My committee must have current club officers to have open communication with the clubs in order to try to make a difference.

Regarding survey question 1, a majority of the clubs that responded did not see a need for officers or AMHA representatives necessary. Though others would like them to be on hand to answer questions regarding how to run a show and show requirements and qualifying. This could be accomplished with a webpage for Local Clubs.

Question 2: Most clubs would see open communication as very desirable. Not feeling they have had a committee to go to that cares about their questions or feedback makes them disgruntle. Some of my feedback was not very cordial but defiant since they have never been asked their opinion before.

Question 3: Some areas are dealing with a lot of shows on the same weekend thus reducing the number of horses. Therefore, profit, barely breaking even and

not enough horses in each class. They find that even when there are rules regarding this sometimes they are not being enforced. Also neighboring local club officials are not working together to reduce this from happening. In other areas this doesn't seem to be a problem. Other clubs do not put on shows due to small participation, aging out with no youth coming up in the ranks and securing judges in their area is cost prohibited.

Question 4: An overwhelming feeling is that a page on our new website should be dedicated to local clubs so they can share what they are doing. "Club Happenings" page to add exposure out there regarding miniature horses. Some clubs do not put on shows but are active in rescue, therapy and other interesting services for their community. There is a need that local clubs can learn new fund raising techniques from each other, sponsorships, about how to put on a successful shows, operations, promotions and other beneficial knowledge.

The Local Club committees has not been active in sometime and from my responses I have received it is an important that we must continue to extend our hand, communication and gain trust with our clubs.

A discussion was held with Pam in the registration department. She had several great suggestions to help our international members with registrations.

1. for new registrations and transfers, do it electronically. Spell the month instead of using number designations because the USA uses different configuration on the numbers for month and day

2. If a registration or transfer is necessary for a show or AOTE qualification, include a note in large writing. An expedite fee can be paid if it is needed immediately. Or after the seven day work time they will give the document high-priority if requested.

3. The office reads and answers other languages with Google translate and also in English. International Members are encouraged to email the AMHA if there any questions about the registration process.

The committee has requested to have amateur and AOTE spotlight articles in the world magazine featuring our international members. The committee will facilitate identifying some of those individuals for spotlighting.

Sami Scheuring has volunteered to compose a letter to be sent to the international directors and international clubs informing them of the requirements to have an approved AMHA international show as stated on page 84 of the rulebook. The international committee will seek sponsors for funding the ribbons for the required seven classes.

Committee members will be assigned a country to work with the international director and affiliated clubs on achieving these goals.

General goals for 2015 will be to increase communication with international members and facilitate promotion of international judges. Revisit the financial support AMHA gives to existing European championship show through USLGE funding.

A subcommittee was formed to investigate the possibility of having an AMHR/AMHA judges seminar in 2015 as a joint venture. This weekend Judges

Seminar is expected to be a stand- alone seminar w/o asking for funds from the EC to make money having consideration with hotel close to airport.

International Judges, USLGE Funds: The Judges, Internationally were being referred to as Temporary Judges. It was decided that those judges should be referred to as International Judges. USLGE has no extra money for continuing seminars in internationally.

There were numerous AMHA Convention Attendees present. A brief orientation was presented to the attendees explaining the duties of the Committee, the Rules governing the Committee, and the Flow Chart. ANNUAL MEETING REPORT FROM AMHA SHOW MANAGER:

2014 was a very positive year for the 3 AMHA Regional Championship Shows and the World Show.

The 2014 Western Regional was held in Reno, NV and had 168 horses in attendance as compared to 170 in 2015. This is a very consistent horse count. More importantly, our total entries were up with 889 class entries. Youth and amateur entries were lower than in Oregon, but open entries were up. The Western averaged 5 entries per horse—a great figure for any event. The Western had the largest number of youth in attendance (41). The show ran late into the evening each day. This was largely due to the tremendous number of entries in hunter (84) and halter obstacle (78). The Western made a profit of approximately \$9000. Many thanks to Sharon Housley for hosting a root beer float party and to Bob & Brenda Kane, Mike & Kerri Griggs and Lori Barile for hosting the youth pizza party.

The 2014 Central Regional was held in Ardmore, OK. We had 152 horses in attendance as compared to 122 in 2013. The show had 688 total entries, up 217 classes from 2013. The Central averaged 4.5 entries per horse and entries were up in all divisions—open, amateur and youth. There were 34 youth participants at the Central. The facility was accommodating and the weather was very cooperative. We only needed air conditioning 2 of the 3 days. Many thanks to Stars Miniatures and JoVon Miniatures for hosting a barbeque for all exhibitors. Thanks also to Lori Walker, SkyMac Ranch for hosting the youth pizza party! Profit on the Central was approximately \$4500.

The 2014 Eastern Regional was held in Springfield, OH. Once again, the Eastern had the distinction of being the largest regional with 237 horses exhibited. The number of horses exhibited at the Eastern has increased every year for the past 3 years. We had 834 total entries as compared to 796 in 2013. All divisions were up and the Eastern had the largest number of Amateur entries of any of the regionals. Many thanks to Brian & Danielle Hill, Danielle Hill Training Center, for hosting an exhibitor dinner party and karaeoke on Saturday night. Approximately \$180 was collected from various exhibitors to defray the costs of our youth pizza party. Profit on the Eastern was approximately \$17,000.

The AMHA World Show was up slightly on horses and up almost 8% on entries. Our total revenue was up about 3.7% due to a decline in sponsorship and vendors. Many thanks to the staff of AMHA for stepping up and making our World Show a success in spite of staff changes prior to our event. AMHA made a profit of approximately \$39,000 without including the Texas grant monies. AMHA will be looking into a new videographer for the AMHA World Show. IEquine will be forwarding a proposal to AMHA to provide these services. Although this would require that we pay for video services, the proposed contract will provide AMHA with a percentage of the banner ad revenue. IEquine did provide AMHA with webcast viewing statistics for the 2014 World Show. The webcast had approximately 65,000 viewers of which approximately 17,000 were "first-time" viewers of the event. Our webcast was viewed in 88 countries. IEquine's proposal will offer both a "free" and "pay-per-view" option for the 2015 World Show webcast.

Laura Mullen informed the board that she had received comments about whether we should continue to offer the World Supreme Champion class. Her contacts had indicated that they felt that the Supreme Halter class diminished the honor of being a Grand Champion for all of those horses who were not chosen. She asked the Board to consider this issue and think about whether they might possibly prefer a parade of grands rather than offering the Supreme class. In addition, Laura invited Alison Rosauer to speak on her idea of offering a nonrated Heritage Grand class for those miniatures 30" & Under.
